Review and approval of the 2011 HOA Annual meeting minutes

Motion to approve the minutes as written and provided in the packet for homeowners made from the floor. Motion seconded. Minutes were accepted as written with no changes.

Roy gave a thank you to Mike Pierce for spearheading the sale of former neighborhood lights. Net gain for the sale was \$1.200.

Financial Report

Ernesto Figueroa presented highlights from the 2011-2012 calendar years.

- 1. Discussed establishment of reserve fund and the process undertaken to determine the appropriate amount.
- 2. Review of financial records and balance sheet
 - a. Main Points. Bad debt running less than anticipated due to lower than expected foreclosure numbers. CD/Savings account balance.

Real Estate Review

Lachlan MacGillivray reviewed sale of local real estate.

- 1. 2011 sales ranged from \$68-\$97 per square foot. \$83 was average
- 2. 2012 sales are running at \$99 per square foot.
 - a. Brookwood is at \$98 per square foot YTD.

State of the neighborhood

Earnesto Figueroa provided a pictorial review of projects completed within RLH during the 2011-2012 year. Monument re-skin, flower and light installation.

Looked to the future with a review of how to take the neighborhood to the "next level." Landscape architects provided drawings for review.

- 1. Improvements to the Gazebo and sitting area
- 2. Improvements to the islands throughout the neighborhood with increased color, shrubbery and rockwork.
- 3. Changes/elimination or alteration of the volleyball and BB court areas
 - a. Suggestions included a sport court, increased sitting areas, play structure,

Suggestions by neighborhood members included a skate half pipe, play structures, increased sitting areas, bocce ball and horseshoes.

Open floor for discussion

Discussion evolved into more suggestions and feedback on the topic of the fence. Consensus being that in as few as two or as many as five years the topic would need to be dealt with again. After meeting wide discussion the topic was floored with the idea of future discussion, additional planning needed.

Charmaine –

Asked for increased communication between the board and the neighborhood. Suggestion was made to make more communication via the quarterly dues notice, web site or via email part of the ongoing effort to include neighbors in the process. Asked for a progress report on the suggestion of speed bumps to help slow down drivers with increased throughway traffic. Asked if green energy options for lighting had been explored.

Pat -

Asked for discussion of reduction of dues.

At this time the discussion of the feedback sought in the mailer sent with the annual meeting announcement was discussed. Neighbors were asked to make sure they provided their feedback and votes on the questions of a) a larger dues reduction, b) smaller dues reduction and slower pace of improvements or c) no reduction in dues and continued, elevated pace of improvements.
